

NATIVE AMERICAN FISH & WILDLIFE SOCIETY: SUMMER INTERNSHIP

Details:

The Native American Fish and Wildlife Society (NAFWS) will be hiring two summer college interns for Summer 2020, who will be based at the NAFWS national office in Northglenn, Colorado. The internship will pay a \$5000.00 stipend to interns who work up to 500 hours.

NOTICE: Due to the changing nature of the current Coronavirus situation across the country, start date of the internship is TBD (to be determined) and may be negotiated.

Responsibilities:

The intern would be responsible for aiding the NAFWS Staff in administrative tasks, assisting the Education Coordinator with implementing the Summer Youth Practicum and other tasks that will enhance and meet the Society's mission as well as its educational and youth endeavors. Interns will also be funded and required to attend and present at the NAFWS National Conference in 2021 about their experience. Interns will be responsible for conducting themselves in a manner that coincides with the Articles of Incorporation, Strategic Plan, Code of Ethics, Conference Code of Conduct and other regulations, policies and procedures. Interns will be in a professional work environment and representing the Society, in which they are expected to conduct themselves in a professional manner and seek guidance and directions from NAFWS staff.

DUTIES

- Assist with the development and implementation of the SYP
- Assist with administrative tasks
- Attend and assist at the National SYP in Estes Park, Colorado, not excluding the possibility of taking the role of counselor
- Present at the National SYP and National Conference of experiences as interns and college experiences
- Serving on a panel at the SYP about college experiences and advice giving
- Aid in creating and maintaining documents concerning SYP participants
- Help in logistical arrangement for the SYP
- Conduct, collect and compile all information from student evaluations
- Help with maintaining the NAFWS youth website
- Work with Education Coordinator regarding the mentoring program
- Complete a short story or essay for the Society's newsletter, Eagle's Nest
- Complete an individual bio for the youth website
- Complete and submit an evaluation of the Society's internship
- Other duties as assigned.

KNOWLEDGE/SKILLS REQUIRED BY THE POSITION

- Currently enrolled student at accredited college/university
- Majoring and/or experience in Education, Environmental or Natural Sciences.

- Effective communication skills. The applicant must demonstrate the ability to communicate effectively both orally and in writing. Ability to deal effectively with personnel from all levels of Tribal, Federal, and State governments, academia, special interest groups and the general public.
- Working knowledge of and respect to Tribal and federal governments, Tribal treaties, agreements, laws, policies, and sensitive issues associated with the management of fish and wildlife resources.
- Must like outdoor activities and camping.
- Indian/Native Alaskan employment preference. As provided in the Society Guide to Personnel Management and as authorized by federal law, the Society will provide an employment preference to applicants who are enrolled members of a federally recognized Indian tribe or an Alaskan village.
- Veteran employment preference. As provided in the Society Guide to Personnel Management and as authorized by federal law, the Society will provide an employment preference to applicants who are veterans of the U.S. Armed Services.

SUPERVISION

• The applicant is under the direct supervision of the Education Coordinator.

PHYSICAL DEMANDS

The majority of the work time will be spent in an office environment and includes standard demands associated with this setting. Minimal lifting of office equipment and other work office environment items may be required. A minimum of 20 pounds may be required to be lifted. Interns must be able to perform physical activities associated with outdoor recreation and camping.
